## **FROM THE PASTOR:** In-person Worship and Congregational Meeting

We are looking to start in-person worship beginning Sunday, September 13. We have hand sanitizer, masks, and will not have congregational singing, as singing is said to be a good way to spread COVID. We also have a plan to socially distance in the sanctuary. As is written in the Massachusetts guidelines, “Attendees who are not part of the same immediate household must be seated at least 6 feet apart. Members of the same immediate household are permitted to sit together and less than 6 feet apart.”

I imagine that household means bubble; if people are in the same bubble, they may sit together. We ask that you keep your mask on while inside the building. People will be asked to sit in a checkerboard pattern. So we have 6 feet of distance between each group.

We will also have speakers pointed out the window toward the front lawn for people who feel more comfortable worshipping in their car or on the lawn. We will be recording and live streaming the worship services and still having Zoom prayer time on Sunday. Shortly before the quarantine started, the boiler that heated the sanctuary broke. After a lot of work, the trustees are presenting a plan for a new, more efficient, heating system. The new boilers will run on propane. The heating system in most of the church will remain the same. The plan is to take out the large steam radiators in the sanctuary and replace them with a hot water system that will heat quicker and more efficiently. Currently it can take two hours to heat the sanctuary from the time the thermostat is turned up. As you can imagine, making steam uses A LOT of energy, and heating giant iron radiators is not a quick way to heat a room. You may find more details on the boiler plans elsewhere in the *Tidings*.

The congregation needs to meet and vote on the plan, and the raising of the money to pay for it. So, after church on September 13, we will have a congregational meeting. We will have it in the sanctuary, with audio also carried on the speakers facing out onto the front lawn, and on Zoom for those who do not feel comfortable attending church in person. This is the first time trying a hybrid congregational meeting; please be patient as I am sure there will be technical difficulties.

We live in a stressful time. We need to think about everything we do. We ask, “Is this safe? Can we make it safer? Is this activity worth the risk?”

We all will have different answers as to what activities we will or won't do. Please do what you feel comfortable doing. If you have questions, please email or call the office, 508-832-2845, and we will try to answer them.

**AN IMPORTANT UPDATE FROM THE BOARD OF TRUSTEES**

The Board of Trustees wants to inform the church of a necessary and unavoidable capital improvement that we have undertaken. We have decided, after many years of repairs and band-aids, that it is time to retire our heating boilers. The reason that now is the time is because the main boiler for the sanctuary is defunct and, even with prayer, cannot be resurrected. Due to its age and years of constant maintenance, we feel it would be a good time to replace the second boiler as well. It will be far less expensive to do these projects together as opposed to paying for the labor twice. Both boilers would be replaced with high efficiency LP gas, forced hot water units. In order to change the sanctuary system, and be more efficient and less costly to maintain, it will mean removing all the old steam piping and radiators and replacing them with a combination of commercial fin tube radiation and fan coil units. This will also give us better control over our energy costs and comfort. We chose an LP system with boilers that can be converted to natural gas in the future if gas lines are laid.

We have already committed \$11,000 to the engineering of this system by Seaman Engineering Corp., which is complete. To remove the existing boilers and radiators, we have a quote of \$5,500 to remove the boilers and pipe plus \$25 per radiator. Expected cost of our oil tank removal is \$4,500, as long as we do not have an oil leak. To install an LP tank will cost roughly \$4,750. We already tested for asbestos at a cost of \$625. So far we have spent \$11,625 in initial cost, and this was taken out of the boiler budget the Trustees had previously set up.

At this time, the Board of Trustees has submitted a warrant for approval to loan invested funds to pay for the project up front, and engage in a capital campaign to replace these funds. The Deacons have also approved a request to provide up to 1/3 of the cost of the project using funds from the Pearl Morrill invested funds. We have requested a special meeting to be held on September 13th after the service. A copy of the warrant for the special meeting is included in this month's *Tidings*.

## FROM THE BOARD OF DEACONS

Sunday “In-Church” Services will begin on September 13<sup>th</sup>.

During Covid-19, the opening of our church doors for Sunday morning service has been a difficult decision, but we now leave the decision of attendance up to each individual. Our first weekly in-person Sunday service will be on September 13, 2020, at 10:00 AM, in the sanctuary. For those that wish to hear the service from outside on the front lawn, or possibly their car, a speaker system will be projecting live via our front sanctuary windows. To reach those that wish to attend from the safety of their home, Sunday services will also be available online. Please look for additional online service information to come via email or call the church office, 508-832-2845.

Below is the list of guidelines that were collectively taken from the required MA Safety Standards and our church committees in order to meet safety compliances within the building. For everyone’s safety and for the safety of staying open, we prayerfully ask that these guidelines be adhered to.

Only one outside entrance will be available for access and will display the Covid-19 rules of entry. Entrance will only be through the front sanctuary door or, if needed, the “sanctuary” elevator. ALL other FCC doors should remain locked. Signage will be posted not to enter at those doors (per MA Safety Standards).

Sanitizers will be located for entry and exit purposes.

Masks - Per the MA Safety Standards: "All attendees and staff must wear face coverings or masks in accordance with COVID-19 Order No. 31 and the Department of Public Health's Guidance while inside and while entering and exiting places of worship or otherwise participating in in-person services, except where a person is unable to wear a face covering or mask because of a medical or disabling condition." (*Masks will be available if not brought.*)

Collection plates will be located at the entrance in the sanctuary (instead of being passed among the pews during service).

Bulletins will not be provided; instead, an electronic Sunday service bulletin will be posted on the FCC Facebook site as well as via an email.

Once inside the building, attendees are asked to go directly to a pew and not gather to socialize. All available (spaced) pews will be clearly marked with a bow and contain a Bible within those designated seating areas. Because no singing is allowed, there will be no hymnals. Music will be offered by our organist and, at times, special accompaniments.

Notification for any prayer requests may be submitted to the church office prior to the Sunday Service. Prayer slips will not be collected during the service at this time.

Exiting the sanctuary should be direct, using the same outside route as was the entry inside (toward sanctuary doors/elevator). Per Mandatory Safety Standards, coffee hour at this time is not allowed. Note: there is access to the restrooms; however, not throughout the building.

*This information is submitted to allow each participant to choose whether to enter the building, or not to enter, given these guidelines.*

On October 4<sup>th</sup>, the Sunday service will include communion with sealed communion cups as well as packaged communion bread. These will be available to pick up upon entry to the church. Outside attendees will also have access to these hosts (from outside).

A decision was made that attendance documentation will not be taken (“Recommended Practice” by the State). Instead, if a case of Covid-19 is reported by someone to the church office or church nurse, then notification (per HIPPA rules) will be addressed accordingly per the church and state procedures.

COVID-19 PUBLIC INFORMATION – TO BE POSTED AT EACH ENTRY DOOR:

Return of anyone after having COVID:

You must quarantine for 14 days and be symptom free for 3 days.

If you have any of the following, we ask that you do not attend church:

- Fever (100.4 Fahrenheit or higher), chills or shaking chills
- Cough (not due to other known causes, such as chronic cough)
- Difficulty breathing or shortness of breath
- New loss of taste or smell
- Sore throat
- Headache, when in combination with other symptoms
- Muscle aches or body aches
- Nausea, vomiting, or diarrhea
- Fatigue, when in combination with other symptoms
- Nasal congestion or runny nose (not due to other known causes, such as allergies), when in combination with other symptoms

We, the Deacons, miss the traditional services we currently long for again. Due to the times we live in today, this lengthy notification has been challenging and may possibly change. Our prayers go out to our church family and friends for your health, patience, tolerance, wisdom, understanding, respect, and, most importantly, faith in God and our church. Enjoy those precious blessings you find in each day and with each other. May God bless you all.

### **Heating System Financing**

Greetings,

As you will find elsewhere in this month's *Tidings*, the heating system for our church is in desperate need of replacement. The upgrade of this system is long overdue. One of the areas of concern with our current oil heating system is the 900-gallon oil tank that is buried outside the church. We know of other churches that have gone bankrupt from cleaning up leaking underground oil tanks, so the sooner we replace ours, the better.

As with past capital projects in our church (roof, sanctuary, driveway), we have asked members to make an additional pledge to help pay the costs associated with the project.

While the Trustees are still waiting for formal bids to be received, they estimate the entire project could cost \$100k to \$150k. The good news is, we already have a substantial amount of money committed to this project. The Pearl Morrill Fund will fund 33% of the cost of the project, up to \$50k. We also have approximately \$23k already donated over the past two years for this project. This means we will need to raise an additional \$44k to \$77k to fully fund this project. Initially, this money will be borrowed from our own invested funds in the form of a loan. We will be asking our members to support a special "boiler pledge" to pay back this loan over the next 2-3 years.

As soon as the Trustees start receiving quotes, they will be communicating via email the details of the amount they will need to borrow to complete the project. A special church meeting will be held on September 13 at 10:35 a.m. to get approval from the membership for this loan. Please prayerfully consider supporting this very important and necessary project.
